1. All entrants must be female members in good standing of the Ohio Women's 700 Bowling Club, the Ohio State USBC and USBC. Check-in is ½ hour prior to the squad time. **Walk-ins must check in 1 hour prior to squad time.**
2. This is a Singles Handicap Tournament. **For 2021 only, three games will be bowled by all entrants** (on the same pair of lanes) to determine the Champion of the Club. Handicap will be based on 90% of the bowler's average from 225. There will be an additional Optional Scratch Division, following the same tournament guidelines.
3. Entrants will use their highest final average from the 2019/2020 winter or summer season in any USBC certified league for 21 games or more. If no average, entrant shall use the highest league average in the 2018/2019 season, provided she has bowled 21 games or more. If no average, entrant may use average at time of bowling (proof will be required). An entrant who has no average meeting the above requirements must enter the Tournament with a scratch average of 225. All USBC and Ohio State USBC memberships, as well as all averages, will be verified through Bowl.com. Failure to use the correct average may subject the entrant to disqualification and/or penalty in accordance with Rule 319A-3. Rules 319A-2, 319C, 319D and 319E will not apply.
4. Prizes will be paid at least 1 place out of every 7 entries. Prize fee will be returned 100%. The additional \$5.00 charged for walk-in entry will be used for Tournament expenses.
5. Current Ohio Women's 700 Bowling Club application and/or dues (\$5.00 for the first year, or \$2.00 for renewal) must accompany the entry (unless already paid).
6. This is a singles tournament. Substitutes are allowed; however, they must meet the foregoing requirements.
7. No open bowling by any of the participants will be allowed on the tournament lanes on the day of the tournament.
8. An entrant arriving late will be permitted to bowl but will begin play with her score to count beginning with the frame then being bowled.
9. All USBC rules will govern this tournament. In the event of a dispute, the Ohio Women's 700 Bowling Club Board of Directors will have the final decision, provided the ruling does not contradict USBC.
10. **Proper attire required (no spaghetti straps, midriff baring tops, short shorts/skirts, low rider pants, no see-through clothing, etc.) Failure to follow this rule may result in disqualification.**
11. **Disruptive and/or unsportsmanlike conduct, profane language and obscene gestures will NOT BE TOLERATED. After the first warning, you will be disqualified from the tournament and no monies will be refunded.**
